Our Current Clinics

Security Deposit Clinic

In this clinic, you will walk a client through the forms and materials needed to file a complaint for the return of their security deposit.

Uncontested Divorce Clinic

In this clinic, you'll help a client prepare and file uncontested divorce documents, and help them avoid costly fees.

Safe Housing Clinic

In this clinic, you will help clients initiate the process to compel landlords to perform repairs and obtain orders against harassment.

Bankruptcy Clinic

In this clinic, you will help clients understand what filing for Chapter 7 bankruptcy would mean for them and how they can file.

I-90 Clinic

This clinic helps clients renew a Green Card or request a new one.

Naturalization Clinic

You will walk people through the process of completing the N-400 naturalization application and assembling the necessary supporting documentation to send to U.S. Citizenship and Immigration Services (USCIS).
